

# RETHINKING AUTHORSHIP AND PUBLICATION IN A GOOD WAY: CENTRING RESPECT, RECIPROCITY, AND RELATIONSHIP

We hope other editors and publishers will draw on this example in their own work. For this reason we offer an exemption to the copyright limitations of this book for this page only. You are welcome to copy, edit, revise, and otherwise evolve this agreement for your own publishing purposes without crediting this source. However, if you draw on the content for the purposes of academic discussions about authorship and publishing principles, please cite us.

## EBOOK LICENSING AGREEMENT

We are grateful for the generosity of time, energy, thought, and care that went into each Collaborators contribution to this book. Our intention, as Editors and as Publisher, is to disrupt colonial and eurocentric practices by ensuring that all Collaborators retain the ownership, control, access, possession, copyright, and jurisdiction over their Work through this licensing agreement.

We acknowledge the colonial and eurowestern ideologies that often play out in academic environments as well as in most publishing practices. One of the ways in which these ideologies are enacted is to require creators to sign over copyright of their Works as part of publishing agreements. This way of viewing ownership stems from colonial worldviews. Some of the Knowledges and Ways of Knowing shared by Collaborators reflect diverse Indigenous identities, cultures, traditions, and self-determination. Non-Indigenous Collaborators shared personal, community, and cultural information specific to their lived experiences and social locations. We respect, celebrate, and honour the Right of each Collaborator to retain ownership, control, access, possession, copyright, and jurisdiction over their Work through this licensing agreement.

This Ebook Licensing Agreement (the “**Agreement**”) covers contributions to the following ebook including any audio, video, visual (art or photos), and written content embedded within or linked from editor or publisher managed URLs to the ebook.

**Ebook:** *Decolonizing health, healing, and care: Embodying culturally responsive and socially just counselling* (hereafter referred to as the “Ebook”).

**Editors:** Sandra Collins and Melissa Jay

**Publisher:** The Ebook will be published through Counselling Concepts (hereafter referred to as the “Publisher”): <https://counsellingconcepts.ca/>.

**Works:** The editors of the Ebook have invited Collaborators to contribute audio, video, visual (art or photos) or written works that will be integrated into the Ebook (hereafter referred to as the “Works”)

## Ebook Authorship and Credits

Each collaborator signing this Agreement (each a “**Collaborator**”) will be listed on the Book Editors and Authors page. There are different ways in which Collaborators’ Works may appear in the Ebook, which will be reflected in individual chapter authorship.

1. Collaborators may contribute a stand-alone chapter in which they are the sole author, or Collaborators may co-author a chapter with other Collaborators. Chapter authorship will be listed with Collaborators in the order specified by the joint Collaborators (e.g., Frank, Groves, and Whitehouse).
2. Collaborators may co-write a chapter with one or both of the Editors. Collaborators will be listed as chapter authors, following the Editors, unless the Collaborators have taken the lead in writing the chapter.
3. Indigenous Elders, Knowledge Keepers, Wisdom Holders, and Scholars may provide Stories, Insights, and/or Teachings that are integrated into a chapter written by the Editors. These contributions will be set apart on separate pages with authorship acknowledged. Indigenous Collaborators will also be listed as co-authors on the chapter, following the Editors, unless the Collaborators have taken the lead in writing the chapter.
4. Collaborators may add practice illustrations to a chapter that is written by the Editors. These practice illustrations are set apart on separate pages, with Collaborator authorship attribution. Collaborators will also be listed as co-authors following the Editors (and Indigenous Teachers or co-writers), in alphabetical order by name.
5. Collaborators may create multimedia objects and works (e.g., art, audio, video multimedia objects and works) for the Ebook. Some of these multimedia objects and works will be reproduced within the Ebook and others require embedded links to the content stored either in Pressbooks, Google drive, or YouTube. These multimedia objects and Works will also have clear authorship attribution to the Collaborator. These Collaborators will be listed as co-authors following the Editors (and Indigenous Teachers or co-writers) and in alphabetical order.
6. In the case of visual artwork licensed for use in the Ebook, without conceptual contribution to a particular chapter, authorship credit will be limited to the credit line beneath the particular artwork.

## Copyright, Ownership, and Licensing Details

Collaborators agree to license the use of their Works to Publisher for the purposes of the Ebook, subject to the terms and conditions below.

1. The Ebook as a whole will be copyrighted by the Publisher for the purposes of registration with Library and Archives Canada, and for sales and distribution of the Ebook.
2. The ownership and copyright of each Work remains with the specific Collaborator or group of Collaborators (in the case of a shared or joint submission).
3. Except for the licenses expressly granted in this Agreement, the Publisher acknowledges that all right, title, and interest in and to the Work (as well as any editorial

modifications made to the Work by the Publisher) are owned and controlled by the Collaborator.

4. By signing this Agreement, Collaborators agree to license their Works to Publisher and Editors on a non-exclusive, royalty-free basis, for use in connection with the Ebook, and subject to the four core principles of the licensing agreement below: nonexclusive, attribution, noncommercial, derivative.
  - a. **Nonexclusive:** Collaborators may share their Works, in their entirety or in part, for personal and professional purposes (e.g., posting a copy on their professional website, conference presentations, sharing a copy with colleagues or clients).
  - b. **Noncommercial:** Requests for use of the Collaborator's published Work in courses should be directed to the Publisher, who will distribute copies of the published Work through an educational institution or directly through the Collaborator by way of Access Copyright licenses. Collaborators will not assign or transfer copyright in their Work, and will not exploit, distribute, license, or transfer the copyright in their Work for commercial purposes (e.g., for reproduction or sale by another Publisher or direct sale by the Collaborator), unless they have agreed to license pre-existing content that is already publicly available elsewhere or that is in the process of being published.
  - c. **Attribution:** When Collaborators refer to their Works or share them, in whole or in part, they will acknowledge the Ebook as the source of the Works, unless they have agreed to license pre-existing content that is already publicly available elsewhere or that is in the process of being published. In all cases, Collaborators may list themselves as the copyright holder of copyright in the Works.
  - d. **Limited Derivatives:** Collaborators can adapt, rework, build upon, and create derivative works from their Works, and make any adaptations they share with others available, with appropriate attributions. However, Collaborators may only adapt, rework, build upon, and create derivative works from Works they have written or co-written. If, for example, a Collaborator's Works are integrated into a chapter by the Editors, the Collaborator will be limited to repurposing their own Work, which will be explicitly delineated as such in the chapter, not the Works of the Editors, other authors of the chapter, or other chapters in the Ebook.

As part of this Agreement, responsibility remains with each Collaborator to ensure that, and each Collaborator agrees that they own the copyright for all audio, visual, or written content in their Works or that this content has an open license that permits commercial use, and that the Collaborator has the right to reproduce all content included in their Works and to grant the licenses granted in this Agreement.

### Usage of the Works

1. The Publisher will ensure that each Work is marked with the name of the Collaborator. The Publisher will not use any copyright notices that conflict with, confuse, or negate those outlined in this Agreement.
2. Once the Works are complete and the Collaborator has signed this Agreement, the Publisher will not translate, edit, alter, modify, or create any derivative works from the Works, except as set out in this Agreement or as otherwise approved by Collaborator, without prior written approval of the Collaborator.

3. Collaborators do not give permission to the Publisher to use their materials in another resource or to license their Works to a third party for any use outside of the Ebook, without the prior written consent of the Collaborators. The Works may be listed in the Ebook table of contents and on the Book Editors and Authors page, both of which will be publicly accessible.

## Royalty Payments

1. Editors are eligible to receive royalty payments from the Publisher, based on a percentage of Ebook sales.
2. The Publisher will also pay a royalty, on regular intervals, to the small group of Indigenous Collaborators whose writings, voices, Stories, and Wisdoms have substantively shaped both the nature and the content of the culturally responsive and socially just (CRSJ) counselling approach that forms the integrative framework for the Ebook. This royalty is intended to honour their contributions to, consultations about, and review of, CRSJ pathways and practices throughout the Ebook. This royalty will be based on a percentage of Ebook sales.
3. All Collaborators are encouraged to link to their professional website, writing (commercial or noncommercial), or other resources on the Book Editors and Authors page in the Ebook or, where appropriate, within a specific Work in the Ebook.

## Term and Termination

1. Permission for the use of Works is granted to the Publisher indefinitely, in relation to the Ebook as well as all of its derivative works, including future revisions and new editions, to be renegotiated only if the Editors create a new edition of the Ebook that involves substantive revisions to the conceptual model and/or to the Works submitted by the Collaborators.
2. This Agreement will not be amended, revised, or revisited if the Editors release a revised version of the current edition of the Ebook (i.e., one that contains relatively minor updates, changes in delivery format), or a new edition of the Ebook that includes additional chapters by new Collaborators.
3. Collaborators may give notice that they wish to terminate this Agreement at any time. However, Collaborators agree that a reasonable timeline for removal of the Work will be negotiated based on the rationale for withdrawal, and the time it will take for the Publisher to issue a new version or edition of the Ebook removing the Collaborator Work(s), which will be a minimum of 6 months from the date of notice of termination.
4. Either party may terminate this Agreement on written notice to the other party if the other party breaches this Agreement and fails to resolve such breach within 30 days of receiving a written notice from the other party. If the Agreement is terminated pursuant to this paragraph, the Publisher will endeavour to remove the Work prior to Ebook sales for the next semester (to minimize disruption to learners in existing courses at Universities or other educational institutions), if possible, or within 60 days from the date of notice of termination.
5. Upon expiry or termination of this Agreement for any reason, all rights licensed under this Agreement will revert immediately to the Collaborator, and the Publisher will provide digital copies of all Works to the Collaborator, in their published format.
